If the escrow account is fully expended during the application process, the Town may require that it be replenished before the Town proceeds further with the application process.</p>

Applicants for a Conditional Use Permit, Rezoning or Comprehensive Plan Amendment, with each application, shall submit \$1,000.00 to apply toward reimbursable</p>	

costs, which sum is to be held by the Town in an escrow account. Applicants for a Site Plan Review, an Erosion Control Permit or Stormwater Permit shall submit an escrow amount based on the Town Engineer's estimate of review and inspection fees. If an applicant submits more than one of these applications covering the same project, then the Town Engineer may reduce the total amount of the initial escrow based upon the scope and complexity of the project. If the initial escrow amount is fully expended during the application process, the Town may request that it be replenished before the Town proceeds further with the application process. Separate escrow deposits shall be required for each plat, certified survey map and other land division to be considered by the Town.
